**No. G.S.R. 9/P.A.2/1993/Ss.25 and 38/Amd.(2)/2024.**-In exercise of powers conferred by section 25 read with section 38 of the Punjab State Board of Technical Education and Industrial Training, Act, 1992, (Punjab Act 2 of 1993), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules, further to amend the Punjab State Board of Technical Education and Industrial Training Service Rules, 2007, namely:-

**RULES**

1. (1) These rules may be called the Punjab State Board of Technical Education and Industrial Training Service (Amendment) Rules, 2024.  
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab State Board of Technical Education and Industrial Training Service Rules, 2007, in Appendix "B",-
  - (i) in serial No. 3, under column 2, the words and signs "Note- The incumbent presently holding the post of Deputy Controller (Finance and Accounts) has been Designated as Controller (Finance and accounts)" shall be omitted ;
  - (ii) in serial No.3 , under column 6,captioned as "Direct Appointment", for the existing item (b), the following shall be substituted, namely:-  
"(b) Should have an experience of working for minimum period of ten years after acquiring the qualification of Chartered Accountant or Cost and Works Accountant.";
  - (iii) in serial no.9, under column 8, for the words "Forty Years", the words " Forty Years in the cases of direct appointment" shall be substituted;

(iv) in serial No 12 and 13, under column 8, the words "Forty-five years" shall be omitted ; and

(v) in serial no.16,under column 8, for the words "Thirty-Five years", the words "thirty-five years for direct appointment" shall be substituted.
